### Features

KOSTER Joint Sealant FS-V is a flexible polysulfide joint sealant. When fully cured, KOSTER Joint Sealant FS-V is a rubber-elastic sealant with a high mechanical load capacity and good resistance to water, sea water, salt solutions, and mineral oils.

#### **Fields of Application**

KOSTER Joint Sealant FS-V can be used to permanently and elastically seal vertical joints in below grade construction, cracks in basements, building foundations, joints in sewage treatment plants, garages, and tunnels.

### Application

The flanks of the joint must be clean, dry, solid, and free of grease and dust. Prime absorbent substrates twice with KOSTER FS Primer; prime non-porous substrates once with KOSTER FS Primer. Do not prime substrates coated with KOSTER VAP I 2000 vapor barriers. Mix components thoroughly using a slow speed mixer for at least 3 minutes, until a homogeneous consistency is reached. Approx. 2 hours after priming, apply KOSTER Joint Sealant FS-V Grey with a caulking gun, trowel, spatula or truing device.
