The long contact time helps to dissolve tough stains and soiling.

KOSTER Façade Cleaning Cream is suited for façades, paving stones, and natural stone. KOSTER Façade Cleaning Cream is not suitable for acid-sensitive surfaces like marble, calcareous sandstone, lime, brick, and certain types of tile. KOSTER Façade Cleaning Cream can lighten the substrate. Always apply a test area to test for changes in shade.

Application

Apply KOSTER Façade Cleaning Cream with a soft brush or roller. Typical contact time is between 5 and 10 minutes. Do not allow the material to dry onto the surface. Keep the surface moist. Dried KOSTER Façade Cleaning Cream can be re-activated with a wet scrubbing brush. After the contact time, brush off the surface with a coarse scrubbing brush with ample amounts of water, or with a pressure washer until all residue is removed.

Approx. 0.02 - 0.05 lb/sq ft; depending on substrate. Approx. 185-450 sq ft/gal
